

**TERMS AND CONDITIONS**

- a)** The firm must submit its tender documents in a sealed envelope (1 Cover) containing Court fees, EMD, OEM certificate, Experience certificate, Dealership Certificate, ISO Certificate 9001 (Optional), Technical bid (Annexure- C), Financial bid (Annexure- D) and Service Centre details (along with contact details) addressed to the **MEMBER SECRETARY, Meghalaya State Legal Services Authority, Superscripting thereon "Supply of Desktop Computers, Printers and UPS"** along with contact numbers.
- b)** The EMD amount, which is *refundable*, should be deposited through bank Demand Draft in favour of Shri. E. Kharumnuid, Member Secretary, Meghalaya State Legal Services Authority, Shillong. For any other details, please visit the O/o The Meghalaya State Legal Services Authority, Old MATI Building, Additional Secretariat, Room No-121, IGP Point, Meghalaya, Shillong-793001.
- c)** The Tender fee, which is *non-refundable*, should be deposited through a Banker's Cheque in favour of the Member Secretary, Meghalaya State Legal Services Authority, Shillong.
- d)** Bidders are requested to quote for original and genuine items only. A certificate or a letter issued by the OEM declaring their firm sells original product is required to be produced along with the tender.
- e)** The tender submitted without Tender fee, Court fee, EMD, OEM certificate, Experience certificate, Dealership Certificate, ISO Certificate 9001 (optional), Technical bid (Annexure- C), Financial bid (Annexure- D) and Service Centre details (along with contact details) will be rejected.
- f)** The bidder having at least 3 (three) years' experience in supply of computers and other equipment's in any Govt./Semi Govt. Dept/PSU/MNC may be preferred.

- g)** The bidders are to fill the details for Eligibility Criteria/Technical bid as per Annexure 'C' and Financial bid as per Annexure "D".
- h)** Tender documents received after the closing date will not be entertained.
- i)** Rates should be quoted inclusive of taxes. Nothing extra shall be paid. The rates quoted shall be valid for the financial year 2024-2025.
- j)** The firm should not have been black listed from any Govt./Ministry/PSU Organization.
- k)** The Authority concerned reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- l)** The decision of accepting authority shall be final.

- a)** The Technical Bid and Financial bid will be opened on the next day after the last date of submission of tender documents in the presence of representatives of the firms/bidders who chose to remain present at the office of the Meghalaya State Legal Services Authority as mentioned in the time schedule.
- b)** The Technical bid will be evaluated first. The bidders not fulfilling technical bid criteria will be rejected and their financial bid will no longer be evaluated.
- c)** Financial bids of only those bidders, whose bids found technically qualified, by the Meghalaya State Legal Services Authority will be evaluated in the presence of the representatives.
- d)** The bidder/supplier who quoted the lowest rates in the financial bid will be considered. Rates should be quoted inclusive of all charges and taxes.
